President Bob Perlman suggested having a one-item agenda for the March 15th Board of Directors Meeting.

Robert Perlman discussed Atlantic Broadband marketing representatives coming to Parker Plaza to explain the services. He will collect the Comcast boxes and bring them to Sheridan and obtain receipts.

It was decided to go over the 4 committees that are formed – Grievance, Event, Budget and Maintenance. The Grievance is required by law. The events committee is needed.

The motion passed by 5 votes.

William Chaiken discussed the AC leaks occurring and when unit owners are not in town. There are alarms that we can ask the residents to purchase and use.

Rosalie Caplan motioned to adjourn the meeting.
